

DECATUR COUNTY COMMISSIONERS

June 1, 2009

The Decatur County Commissioners opened their June 1st, 2009 meeting with the following present: Jerome Buening, President, John Richards, Rick Nobbe and Bridgett Weber – Auditor

The May 18th 2009 meeting minutes were approved as corrected.

Mark Mohr – Highway Superintendent reported that Bridge 115 & 190 was opened after last meeting. Mr. Mohr provided his annual report that is due to the State Board of Accounts. Mr. Mohr will be taking a closer look at chip and seal projects for 2009; monies have been reviewed for first quarter and a minimal amount work may have to be scheduled to meet cash flow allowances.

Payroll Claims and Accounts payable claims were approved.

Andy Scholle was contacted by the Rush County Surveyor. 3 tracts of land in Decatur County have water running into properties in Rush County. Mr. Scholle has been asked by Rush County to survey the area. Mr. Scholle says it will cost approximately \$2,000.00 for his company to survey this property. After discussion with Mr. Mohr and the Commissioners, Mr. Scholle will be looking into this further and continue discussions with Rush County.

David Fry - Decatur County Memorial Hospital presented the AED equipment to the Commissioners. Planning for training is being scheduled by Tony Blodgett.

Bill Ulerich - QPH reported that the motors that need to be replaced should be here on Tuesday or Thursday. 8 out of 14 motors are bad; 1 out of 2 coils are bad. Mr. Ulerich will continue to update the Commissioners and the Auditor's Office.

Bob Rynard - DGDC Car Show requested use of the courthouse grounds and restroom facilities July 24th and 25th. Commissioners agreed to the use of courthouse grounds and building for restroom facilities provided that security is present.

Charlie Greiwe – Property owner on Park Road requested some guidance on how to remove excess water between his property, Joey Roberts and golf course. Mr. Mohr offered to look at the property to see if any of the drains installed by the county when the road was changed to a T intersection could be causing the problem. Mr. Nobbe also recommended Mr. Greiwe talk to John Fox at the golf course.

Region 9 Workforce Board – Mr. Nobbe attended the meeting last week and reported that Work One and this board is busy retraining workers to get them back out into the workforce.

Ms. Polanski reported that Alan Crosby at the Health Department has had some problems getting the permits issued for property owners in Sardinia but they will be issued soon. Ms. Polanski is going to send a follow up letter and ask property owners in Sardinia to hire their installers and have them installed by July 20th.

Joey Roberts invited everyone to come to the final weekend of the spring youth soccer league.

With nothing else to come before the Commissioners Mr. Nobbe moved to recess, Mr. Richards seconded and Mr. Buening concurred.
