DECATUR COUNTY COMMISSIONERS

September 20, 2010

The Decatur County Commissioners opened their September 20, 2010 meeting with the following present: Jerome Buening-President, John Richards and Bridgett Weber–Auditor

The September 7th 2010 meeting minutes were approved as read.

Payroll Claims and Accounts payable claims were approved

Mark Mohr – Highway Superintendent provided information on the RFP's for Bridge #19; work is completed on 200E looks good and drives good hoping it lasts through winter.

On 421 North some milling work was done to try and smooth out the issues. Mr. Mohr said it will take some larger funding to correct this issue more permanently.

Pricing for trucks was discussed. County Chevrolet and Sibbitt Chevrolet were low bidders for the trucks so Mr. Mohr will wait to here from Commissioners before ordering.

Marvin Rees and Andy Scholle were present to discuss drainage issues in Williamstown. Mr. Rees provided maps to show the drainage issue caused by a landowner in Decatur County when railroad ties were removed. Mr. Richards moved to give Rush County jurisdiction on the current Williamstown issue and Mr. Buening concurred.

Andy Beetz provided the petition for the extension of CR 100S for the St Mary's Church and School project. Mr. Beetz also discussed how the land would be affected in the areas where the road would change. Mark Ricke showed the Commissioners some pictures of the concerns of his property. Mr. Richards moved to give St Mary's permission to extend CR 100S that intersects with 421 South and Mr. Buening concurred.

Hugh Miller – EMA Director provided a report from Emergency Management.

Commissioners reviewed the request for facilities forms and will continue to receive information from Ms. Polanski. Mr. Richards moved to approve the **Declaration of Emergency and No Burn Declaration for Decatur County** and Mr. Buening concurred.

Mr. Richards reported that all permitted properties in **Sardina** have been installed. There are two properties that have not been installed and it was questioned whether their permit time has expired. Commissioners agreed to allow Ms. Polanski to bring court action to these two owners that have not installed systems.

With nothing further to come before the Commissioners, Mr. Richards moved to recess and Mr. Buening concurred.
